6:02 Open Time to the Public

Glenn West asked if he could remove two dead trees on the bank to the Manhan River at the Lyman Sheet Metal property. The trees had been noted in the Lyman Pond dam removal project. The stumps would remain in place. The Commission said that the two trees in question could be cut down since they were to remove the hazard.

Stewardship Projects

6:06 Szczypta Conservation Farm & Barn

Securing broken open side of lower level of barn - R. Fletcher said he had contacted Mark Sarafin (who had previously installed new doors on the barn several years ago) to add another sliding door in the section where the siding had been removed. The other doors will remain. The new door will provide better access for loading/unloading hay in that section of the barn. At a Select Board meeting earlier in the year, the Fletchers had been told they could do whatever they wanted with the barn using their own funds. M. Hanc noted that while the Fletchers could use their own funds, the lease states that for changes to the property, the lessee must obtain "prior written consent of the Town, including the Board of Selectmen, Conservation Commission and Water Commission". The Commission should be given a copy of the new door plan for approval when it is available. A building permit will be needed for the new door. While the barn is not secure while the siding is off, it was noted that during weekdays there is a police officer across the street at Glendale Rd for the road reconstruction project.

Foot Traffic Only signs – Will be installed by September 16 meeting. Location left to Fletchers to avoid problems with farm machinery plus they know where damage has been done to fields by unauthorized vehicles.

Condition of fields – The fields appear in good condition with no adverse impact from road work. It has been difficult getting large equipment into the fields.

Condition of trail – The back section of the fields, where the trail is located, have been wet. Drainage ditches need to be cleared out.

Meeting with David Cameron – Stream crossing needs to be widened to better allow equipment access to back fields. D. Cameron had offered to assist in filling out paperwork.

Coordinate with Kestrel about location to install new nest box – New nest box and post are ready for installation.

6:32 Clearwater Woodland Conservation Area

Northeast Survey Consultants expects to be finished blazing the boundary by August 23. B. Taylor reported a downed tree which should be removed from across the trail.

6:34 Pomeroy Mt/Durell's Path

C. Axthelm, B. Taylor, and J. Piper will arrange a date for installation of the boundary medallions. Costs from at least three Foresters must be obtained before the Commission can hire someone to create a Forest Cutting Plan based upon the Forest Management Plan. If cost estimates can be received soon, a special meeting can be scheduled to vote on hiring prior to the next regularly scheduled meeting on September 16.

6:38 Manhan Meadows Sanctuary

The August 7 storm caused considerable damage to the property. Trails were assessed August 10 by A. Lawrence and M. Hanc, August 13 by C. Axthelm, M. Hanc, K. Labrie, and J. Labrie, and August 14 by C. Axthelm and T. Zaharias.

Funding available for tree work was discussed, including the impact of using up endowment funds for maintenance rather than using those funds to leverage grants.

7:09 Motion made by A. Lawrence, seconded by J. Piper to pay up to \$150 for signs notifying people that the Manhan Meadows Sanctuary and Parsons Memorial Trails are closed due to the damage to the trees from the storm. Motion passed unanimously with six (6) Yes votes.

7:10 Volunteers

Another work day is planned for September 21. Whittemore and Wolf Hill have trees down.

7:14 Follow up EO NOI DEP#289-0214, 71 Whiteloaf Rd

The deed for a new owner of the property was recorded on July 26, 2019. There was a degree of uncertainty as to which deed should be used for recording the EO. Calls will be made to DEP and MACC to ask. The Commission members requested that a letter be sent to the new owner to be sure he is aware of the outstanding OOC and EO, and to invite him or his representative to the Conservation Commission meeting on September 16, 2019 to review the project with him.

7:21 Follow up EO, 114 County Rd

The property owner was to have planted a mix of grasses (Red Fescue, Little Bluestem, and Big Bluestem), to stabilize the soil. From County Road, it does not appear that those grasses have been established, but the site is vegetated. The Commission will continue to monitor the site from County Road.
