

Fall Celebration/Scarecrow Invasion-Witches Ride/Brew Fest Parks and Rec and Economic Development Commission discussed the possible conflict of our naming our September event "Fall Celebration" with the October Event sponsored by the AEDC. A committee member of the AEDC voiced concern over the term "Fall" being used on our Upcoming Events Flyer And causing confusion with their event in October, date TBD. The Parks and Rec Committee does not feel this is a conflict as the AEDC has not given us a specific name for their event other than a Witches Ride/Brew Fest. Parks and Rec came up with the idea of cross promoting both events with a 2 sided flyer but this offer was declined. Town Administrator came up with creative ideas to address these concerns by advertising the Fall Celebration kicking off with the Scarecrow Invasion to be followed by the Witches Ride.

Member of the AEDC was asked to forward us a contact list from their 2017 Scarecrow Invasion and their January 2018 Bonfire.

Discussions were held about our "Upcoming Events Calendar" Flyer. Flyers handed out at Briggs School, Senior Center, Businesses and at the Community Day held in town. Our Summer Concert Series is also published in the Johnny Appleseed Magazine.

## Tree Lighting

DPW will be addressing and working with the AMLD and an electrician to resolve past ongoing electrical issues with the lighting of the trees. Electric is needed on the green space and each tree.
