OLD/NEW BUSINESS: John reported on the housing violations reported by the tenant at an illegal apartment at Pires 17-140. An order to repair has been issued. John gave the Board copies of a letter and associated information regarding a noise complaint against Animal Health Care located at the Martha's Vineyard Airport. The complaint is from Elaine & Gary Friedman, 8 Coffins Field Road, Edgartown Ma. The Friedman's are citing the DEP noise regulation 310 CMR 7.52 and would like to get on an agenda in August to discuss the complaint. DEP has issued a Notice of Non Compliance for not having a water systems operator with a 1T rating for the West Tisbury Town Hall. The Board has directed the Agent to apply for a six month temporary license until a resolution can be determined. John granted a one week extension for Housing repairs at Seward 16-192. The Selectman granted access to legal services and John has forwarded the Smith College 10-100 law suit to the Town's Attorney.
